### PATHWAY TOWARD SHAPING OUR FUTURE TOGETHER

## STEERING TEAM REPORT

In 2023, the Pathway Forward Steering Team began a two-year strategic planning process, as developed by the Mosaic Board and affirmed by a majority of delegates at the November 2022 Conference Assembly. We seek to set a pathway within our priorities and in alignment with our vision and mission, which will serve to guide us for the following 3-5 years in our work together as congregations, Conference Related Ministries, Board (CRMB), and staff. This work will also clarify our relationship with Mennonite Church USA (MC USA), with each other, and with other Anabaptist communities.

As stated in the <u>Pathway Forward</u> document, we "recognize the holy possibility present in living into our vision; we have committed to embodying the reconciling love of Jesus in our broken and beautiful world as a community celebrating and extending God's grace, justice, and peace. We recognize that, by the power of the Holy Spirit, we shape our relationships and work around missional, intercultural, and formational priorities with Jesus at the center of our faith."

We have been meeting regularly as a team since April 2023. Our team consists of a smaller coordinating group and Grovider, our consulting group. June and July were critical months for conversations and data gathering. During these two months, 16 focus group sessions (approximately 125 participants) and 14 individual interviews were hosted by the team and Grovider. These groups included: credentialed leaders, lay leaders, young people, board members, Conference Committee chairpersons, Conference staff, and leaders. The questions in the group sessions focused on these areas.:

- Consider Mosaic's priorities--missional, intercultural, and formational. How are these being carried out? Please specify which priority you're speaking of when you answer.
- What resources or supports are needed to ensure Mosaic fulfills its priorities?
- Are MC USA and Mosaic's priorities aligned? If so, how? If not, where is the disconnect?
- What, if any, are the advantages and disadvantages of the relationship between Mosaic and MC USA?
- When there are differences in beliefs, practices, and issues with control, how is this conflict addressed?
- What has worked or what could be improved? What expectations do you have of your Conference Board and staff? How have they achieved these expectations? What could be improved?
- How important is it that Mosaic members and leadership operate in accordance with the Spirit? What does this mean to you? What suggestions do you have for improvement in this area?
- What are your general hopes and dreams for Mosaic Conference in the next five to seven years?

Overall, the dialogue was rich and diverse, as leaders from congregations and CRMs, staff, and Board members grappled with our calling and priorities as a conference and broader denomination, amid the challenges of this season.

The findings from these focus groups and interviews will be presented at the Delegate Preparation Meetings and at Fall Assembly. During those times, additional space will be provided for discernment and feedback. The gathered information will guide the next phase of the team's work.

We encourage you to continue to fast and pray for listening, discernment, and yielding to God's Spirit in the work of the Mosaic Conference and the Pathways Process. We welcome any feedback and questions that you may have. Please reach out to any member of the Pathways Steering Team.

### **FINANCIAL REPORTS - 2023**

**EXECUTIVE SUMMARY FOR 2022-23** 

**REVENUE:** Mosaic Mennonite Conference's operating revenue comes from two main sources, Conference congregations and rental income from the Conference-owned properties (the Souderton Center & the Indian Creek Road farm), in the form of subsidy to the Conference budget.

- Congregational Giving \$389,197
- Subsidy from Properties \$484,992
- All Other Revenue Sources \$148,597

Note that estate gifts (included in Other Revenue) received by the Conference do not go into the operating budget, but into Ministry Resource investment funds, which are used mostly for Missional Operations Grants. \$116,530 in estate gifts was received last year. Other Revenue also includes restricted contributions like those for New Missional Initiatives, as noted below. Investment gains or losses are also recorded as Other Revenue, and this past year we experienced a loss of \$190,547 in our investments, for both the Conference and properties.

**EXPENSES:** Expenses are divided into two basic categories, Program or Ministry expenses and Support Services expenses. The industry standard for non-profits is 75%-25%, respectively, and this past year, Mosaic was above the standard, at 86%-14%, respectively.

- Missional Operations Grants (MOGs) \$116,672. Last year, 17 MOGs were disbursed to ministries and congregations of Mosaic Conference:
  - » Nueva Vida Norristown New Life received a grant for their Summer/Fall Outreach ministry.
  - » Rocky Ridge received a grant for their partnership with Peace Proclamation Ministry International.
  - » West Swamp received a grant for a ministry partnership with Crossroads Community Center.
  - » Salford received a grant for their Gardening for Peace event.
  - » Plains received a grant for their playground ministry.
  - » Nations Worship received a grant for their Youth and Children's initiative.
  - » Centro de Alabanza received a grant to assist in the purchase of their parsonage.
  - » Finland and Ripple received grants towards Ripple's purchase of their building.
  - » Salem received a grant for their Drop Kids initiative.
  - » Vietnamese Gospel received a grant for their discipleship classes and retreat.
  - » Vincent received a grant for their partnership with Open Door.
  - » Lakeview received a grant for their partnership with Whitehall.

- » Mennonite World Conference received a grant to assist in translation work during their assembly in Indonesia.
- » Indonesian Light received a grant to assist their pastor in getting a visa.
- » Several congregations received assistance for their involvement in the conference's Borderlands and Ambassadors programs.
- » Funds from the MOG fund were also allocated for use in the Pathway Process.
- \$20,134 in Church Plant grants were given to Centro de Alabanza, Seguidores de Cristo, Anabaptist Mennonite Network, Refuge and the CIEAMM church conference in Mexico.
- Seven Leadership Training Scholarships totaling \$11,800 were distributed for leaders in conference congregations.
- New Missional Initiatives \$68,411. These activities have received their own restricted funding, e.g., Shalom Mutual Aid Fund, Pastoral Assistance Fund.
- Staff Travel \$78,046 (found in most expense departments). 64.5% of this expense went to Leadership ministers traveling in their Leadership Ministry roles.
- Staff time and benefits (including contracted workers, but not properties management) \$696,533, which is allocated over most of the expense departments based on staff activities. This made up 64.8% of the total Mosaic operating expenses last year, which does not include funding for designated new missional initiatives.

**THE WORM PROJECT:** In 2022, The Worm Project received \$290,989 in donations and \$701 in book sales. They purchased \$268,958 in Worm Medicine, had \$2,777 in book costs, and had \$9,879 in Administrative and Overhead costs.

# CONFERENCE BOARD / FINANCE COMMITTEE REPORT - 2023

### **2022-23 UPDATES/ACTIVITIES:**

The CBFC spent considerable time discussing:

- 1. the various investment funds of the conference and properties: Missional Operations Grant funds held with the Mennonite Foundation and Franconia Board of Missions and Charities (FMC) Properties Capital Reserve Fund investments held with SEI Investments & Everence Federal Credit Union;
- 2. the financial activities are in keeping with the vision and mission of the Conference;
- 3. the financial effects on various property-related issues; and
- 4. determining cash flow needs (amounts and timing) for the Conference and the properties, including future capital expenditure needs of the Souderton Center and Indian Creek Road farm.

CBFC members routinely reviewed Mosaic's financial reports, and provided reports to the Conference Board regularly, monitoring operating expenses with the budget and ensuring adequate cash flow.

CBFC members developed a budget for the current year in line with the vision and mission of the conference. They also looked at various clues to the future.

The CBFC committed to ensuring that the Conference staff are good stewards of the assets and resources that have been entrusted to Mosaic by Conference congregations and constituents, and that those resources are used appropriately and in alignment with the vision and mission of the Conference. Mosaic received a clean financial review report this past year, assisting us to maintain the funds and reports with good accounting practices.

### MINISTERIAL RETIREMENT FUND SUB-COMMITTEE:

This committee, which is under the CBFC, met once to review the financial needs of those pastors and spouses who are eligible for assistance under the Ministerial Retirement Fund guidelines. This fund provided assistance to one person. \$8,420 was distributed in retirement assistance this past year. The committee members are: Marvin Anders (Salford) and John Goshow (Blooming Glen).

# FRANCONIA MENNONITE BOARD OF MISSIONS AND CHARITIES

**AKA FMC PROPERTIES** 

At the end of this fiscal year, FMC Properties owned the following properties: the **Souderton Shopping Center**, with tenants Care & Share Shoppes, Weaver, Reckner and Reinhart Dental Associates (Souderton office), and TriValley Primary Care (Indian Valley office); the **Indian Creek Road farm**, with tenants Living Hope Farm and Indian Creek Foundation (group home); **Crossroads Community Center**, "inherited" at the merger of Eastern District and Franconia Conferences; **Roaring Spring Mennonite Church**, transferred to us when the church was closed (and subsequently sold in July 2023); and two other church properties: **Whitehall Mennonite Church** and **Bike & Sol** (the former Peace Mennonite Church).

### 2022-23 UPDATES/ACTIVITIES:

### FMC Properties directors discussed:

- The Souderton Shopping Center: renegotiated two new lease agreements with existing tenants and negotiated a short extension with another tenant; completed repairs to HVAC units, a chimney, replaced rear-entry doors. Completed the lease agreement with one tenant and processed the lease for an existing tenant to take over that space. Repaired a roof that was leaking and repaired the landscaping with new plants;
- The Indian Creek Road farm: replaced the water softener for the Indian Creek Foundation group home;
- The Emily Street property was sold to Centro de Alabanza.
- Conference-owned church properties: property ownership issues, including the transfer of ownership of the Roaring Spring church property to Franconia Mennonite Board of Missions and Charities' name and prepared for the property's sale.
- The directors continue to plan for the future of the Souderton Shopping Center.

### **INTERCULTURAL COMMITTEE REPORT - 2023**

Mosaic Mennonite Conference is committed to being a church that goes beyond surface-level diversity toward true racial justice for all people. While our world's economic and governmental systems present differences among us as threats to be eradicated, we aim to develop multicultural communities of faith that show our broken world a new way of living.

### 2022-23 UPDATES/ACTIVITIES:

- From February to April, we held another Conference-wide book study of the book, *Been in the Struggle: Pursuing an Antiracist Spirituality*, by Regina Shands Stoltzfus and Tobin Miller-Shearer.
- We have continued to increase the participation of BIPOC (Black, Indigenous, & People of Color) leaders in Mosaic, with representation on Boards and Committees.
- In July, the Committee took the Intercultural Development Inventory (IDI) to better
  understand the intercultural work of the Conference and have a common language.
  Additionally, the Committee recommended that the Board would complete the IDI, which also
  took place in July.
- The committee started a White Caucus group to create space for persons of the dominant culture to work at antiracism and identity formation apart from BIPOC.
- A Renewing Nations and Generations Gathering for BIPOC groups is being planned for November 2023. This year, the White Caucus group and the Intercultural Class from Mosaic Institute will be invited to participate in the gathering.

This past year, great strides have been taken to become more intercultural as a Conference. This work is not always easy. Yet, there is a large percentage of the Conference that wants to see this priority of the Conference lived out. We must keep moving ahead and use this momentum to take the Conference to the next level. We are at the point where our intercultural priority is being tested. It may feel uncomfortable, but let us reflect on the work being done and lean in together.

### **ASSEMBLY MINUTES**

NOVEMBER 5, 2022 SOUDERTON (PA) MENNONITE CHURCH

### FIRST ASSEMBLY SESSION: REPORTING

- 1. The Minutes of the 2021 Conference Assembly were presented and affirmed by a voice vote.
- 2. The delegates participated in a Bible study explaining and experiencing the concept of *Chesed*. Tamales were an important object lesson.
- 3. The new member congregation Evangélica Menonita de Oración y Adoración and the new conference related ministry Amahoro International were presented to the delegates by assistant moderator Angela Moyer Walter. Noel Santiago led in a prayer of thanksgiving and commissioning.
- 4. Angela Moyer Walter of Ripple congregation and Roy Williams of College Hill Mennonite Church were affirmed by a 95% affirmation as the new moderator and assistant moderator, respectively. Glen Guyton, Executive Director of MC USA, led in a prayer of blessing.
- 5. Jenny Fujita, Aldo Siahaan, and Nathan Good presented findings from the Listening Task Force, which had been engaged since July 18, 2022, in conversations with Conference congregations and Conference-Related Ministries (CRMs) in preparing for a strategic planning process.
- 6. Marco Güete led in a prayer for the noon meal.

### **WORSHIP BETWEEN DELEGATE SESSIONS:**

Associate Executive Minister Marta Castillo led a service of remembrance for leaders who have passed away during the past year and a service of anointing for the twelve new leaders serving in Mosaic Conference.

### SECOND ASSEMBLY SESSION: DISCUSSING

• Leadership Minister Danilo Sanchez led in prayer and the delegates discussed at their table groups the FAQ summary document created by the Listening Task Force. The primary question that was reflected upon was, "What might Mosaic Conference look like in the next 3-5 years?"

The delegate session took a recess to engage in a time of worship and communion.

### THIRD ASSEMBLY SESSION: DECIDING

- 1. The Pathway document was formally presented and discussed. At the end of discussions, Ertell Whigham led a prayer for discernment and wisdom as the delegates acted on the proposed Pathway document.
- 2. A ballot was cast, allowing for a) affirmation of the document, b) affirmation with reservations, and c) not affirming the document. Of those delegates present, 81.5% gave affirmation or affirmation with some reservations to the Pathway document as presented.

- 3. Leadership Minister Noel Santiago shared from Matthew 13:44-46, and invited the delegates to reflect on the following questions:
  - What treasures have we discovered?
  - What possibilities do we see?
  - What pain persists?
  - What hopes do we have?
- 4. The delegate session closed with a reading from 1 Peter 1:6-7, prayer, and adjournment.
- 5. Our next delegate meeting is scheduled for November 4, 2023.
